

## PATRIOT GOLD CORP Rank 2 of 72



The relative strengths and weaknesses of PATRIOT GOLD CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PATRIOT GOLD CORP compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 138% points. The greatest weakness of PATRIOT GOLD CORP is the variable Assets, Current, reducing the Economic Capital Ratio by 55% points.

The company's Economic Capital Ratio, given in the ranking table, is 327%, being 337% points above the market average of -9.6%.
