

The relative strengths and weaknesses of HYCROFT MINING HOLDING CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HYCROFT MINING HOLDING CORP compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 42% points. The greatest weakness of HYCROFT MINING HOLDING CORP is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 71% points.

The company's Economic Capital Ratio, given in the ranking table, is -43%, being 33% points below the market average of -9.6%.
