

DYNARESOURCE INC Rank 53 of 71



The relative strengths and weaknesses of DYNARESOURCE INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of DYNARESOURCE INC compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 63% points. The greatest weakness of DYNARESOURCE INC is the variable Other Expenses, reducing the Economic Capital Ratio by 153% points.

The company's Economic Capital Ratio, given in the ranking table, is -5.9%, being 60% points below the market average of 54%.
