

ATHENA GOLD CORP Rank 17 of 71



The relative strengths and weaknesses of ATHENA GOLD CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ATHENA GOLD CORP compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 286% points. The greatest weakness of ATHENA GOLD CORP is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 30% points.

The company's Economic Capital Ratio, given in the ranking table, is 149%, being 96% points above the market average of 54%.
