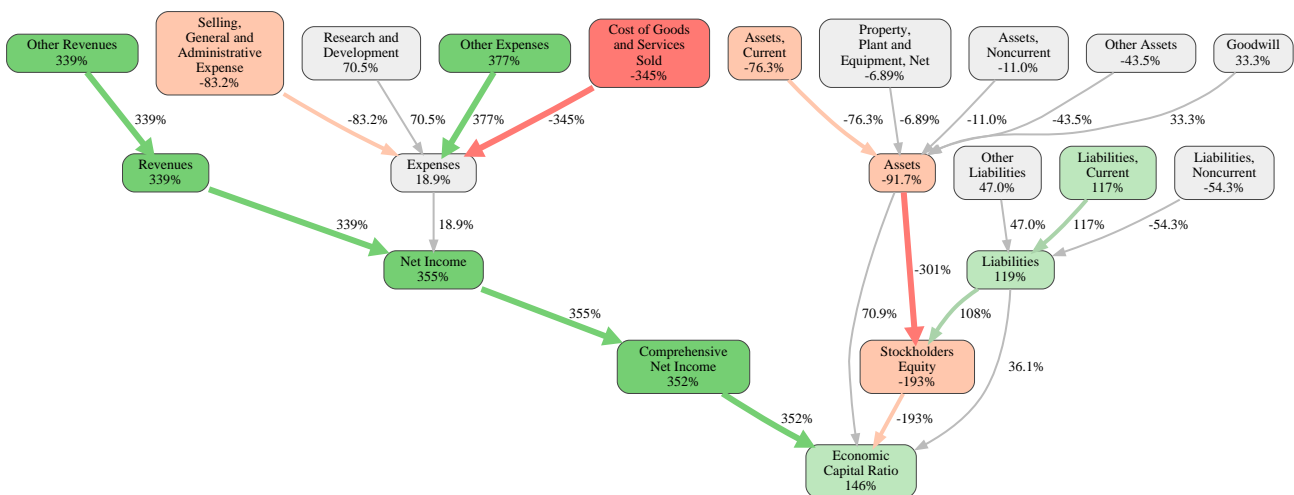

The relative strengths and weaknesses of LCI INDUSTRIES are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of LCI INDUSTRIES compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 377% points. The greatest weakness of LCI INDUSTRIES is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 345% points.

The company's Economic Capital Ratio, given in the ranking table, is 154%, being 146% points above the market average of 8.6%.
