

The relative strengths and weaknesses of ARCH CAPITAL GROUP LTD. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ARCH CAPITAL GROUP LTD. compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 38% points. The greatest weakness of ARCH CAPITAL GROUP LTD. is the variable Revenues, reducing the Economic Capital Ratio by 32% points.

The company's Economic Capital Ratio, given in the ranking table, is 37%, being 6.6% points below the market average of 44%.
