

The relative strengths and weaknesses of HUMANA INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HUMANA INC compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 1,116% points. The greatest weakness of HUMANA INC is the variable Policyholder Benefits and Claims, reducing the Economic Capital Ratio by 713% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 44% points above the market average of 53%.
