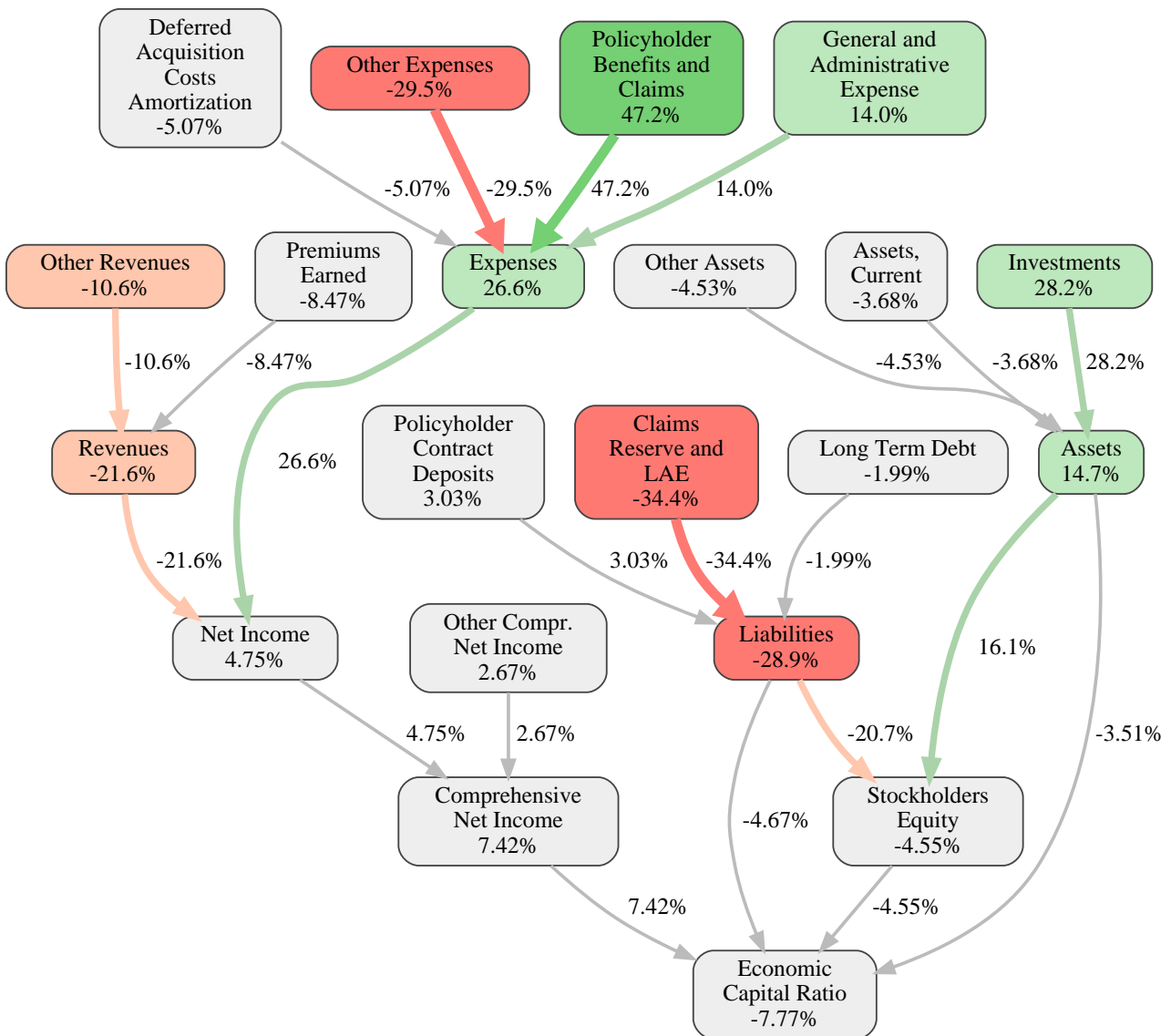

The relative strengths and weaknesses of CNA FINANCIAL CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of CNA FINANCIAL CORP compared to the market average is the variable Policyholder Benefits and Claims, increasing the Economic Capital Ratio by 47% points. The greatest weakness of CNA FINANCIAL CORP is the variable Claims Reserve and LAE, reducing the Economic Capital Ratio by 34% points.

The company's Economic Capital Ratio, given in the ranking table, is 27%, being 7.8% points below the market average of 35%.
