

## MOLINA HEALTHCARE INC. Rank 21 of 76

The relative strengths and weaknesses of MOLINA HEALTHCARE INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MOLINA HEALTHCARE INC. compared to the market average is the variable Premiums Earned, increasing the Economic Capital Ratio by 576% points. The greatest weakness of MOLINA HEALTHCARE INC. is the variable General and Administrative Expense, reducing the Economic Capital Ratio by 916% points.

The company's Economic Capital Ratio, given in the ranking table, is 43%, being 17% points above the market average of 26%.
