

ANADARKO PETROLEUM CORP Rank 18 of 79



The relative strengths and weaknesses of ANADARKO PETROLEUM CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ANADARKO PETROLEUM CORP compared to the market average is the variable Long-term Debt, increasing the Economic Capital Ratio by 40% points. The greatest weakness of ANADARKO PETROLEUM CORP is the variable Depreciation, Depletion, Amortization, reducing the Economic Capital Ratio by 10% points.

The company's Economic Capital Ratio, given in the ranking table, is 183%, being 128% points above the market average of 55%.
