

The relative strengths and weaknesses of RedHawk Holdings Corp. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of RedHawk Holdings Corp. compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 97% points. The greatest weakness of RedHawk Holdings Corp. is the variable Oil and Gas Property, reducing the Economic Capital Ratio by 53% points.

The company's Economic Capital Ratio, given in the ranking table, is -74%, being 144% points below the market average of 70%.
