

## EMPIRE PETROLEUM CORP Rank 85 of 89



The relative strengths and weaknesses of EMPIRE PETROLEUM CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of EMPIRE PETROLEUM CORP compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 63% points. The greatest weakness of EMPIRE PETROLEUM CORP is the variable Oil and Gas Property, reducing the Economic Capital Ratio by 98% points.

The company's Economic Capital Ratio, given in the ranking table, is -182%, being 212% points below the market average of 29%.
