

The relative strengths and weaknesses of QEP RESOURCES INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of QEP RESOURCES INC. compared to the market average is the variable Long-term Debt, increasing the Economic Capital Ratio by 40% points. The greatest weakness of QEP RESOURCES INC. is the variable Other Revenues, reducing the Economic Capital Ratio by 12% points.

The company's Economic Capital Ratio, given in the ranking table, is 198%, being 168% points above the market average of 29%.
