


OCCIDENTAL PETROLEUM CORP DE Rank 12 of 84



The relative strengths and weaknesses of OCCIDENTAL PETROLEUM CORP DE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of OCCIDENTAL PETROLEUM CORP DE compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 44% points. The greatest weakness of OCCIDENTAL PETROLEUM CORP DE is the variable Revenue from Contract with Customer, reducing the Economic Capital Ratio by 35% points.

The company's Economic Capital Ratio, given in the ranking table, is 183%, being 114% points above the market average of 69%.
