

The relative strengths and weaknesses of SYNCHRONOSS TECHNOLOGIES INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SYNCHRONOSS TECHNOLOGIES INC compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 32% points. The greatest weakness of SYNCHRONOSS TECHNOLOGIES INC is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 80% points.

The company's Economic Capital Ratio, given in the ranking table, is 114%, being 25% points below the market average of 139%.
