





The relative strengths and weaknesses of FARMHOUSE INC. NV are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of FARMHOUSE INC. NV compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 135% points. The greatest weakness of FARMHOUSE INC. NV is the variable Other Assets, reducing the Economic Capital Ratio by 183% points.

The company's Economic Capital Ratio, given in the ranking table, is -541%, being 567% points below the market average of 26%.
