

The relative strengths and weaknesses of Claros Mortgage Trust Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Claros Mortgage Trust Inc. compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Claros Mortgage Trust Inc. is the variable Other Liabilities, reducing the Economic Capital Ratio by 106% points.

The company's Economic Capital Ratio, given in the ranking table, is 70%, being 27% points below the market average of 97%.
