## TWDC Enterprises 18 Corp. Rank 2 of 29

The relative strengths and weaknesses of TWDC Enterprises 18 Corp. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of TWDC Enterprises 18 Corp. compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 219% points. The greatest weakness of TWDC Enterprises 18 Corp. is the variable Other Expenses, reducing the Economic Capital Ratio by 22% points.

The company's Economic Capital Ratio, given in the ranking table, is 254%, being 411% points above the market average of -157%.
