



The relative strengths and weaknesses of TABLE TRAC INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of TABLE TRAC INC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 412% points. The greatest weakness of TABLE TRAC INC is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 222% points.

The company's Economic Capital Ratio, given in the ranking table, is 288%, being 932% points above the market average of -643%.
