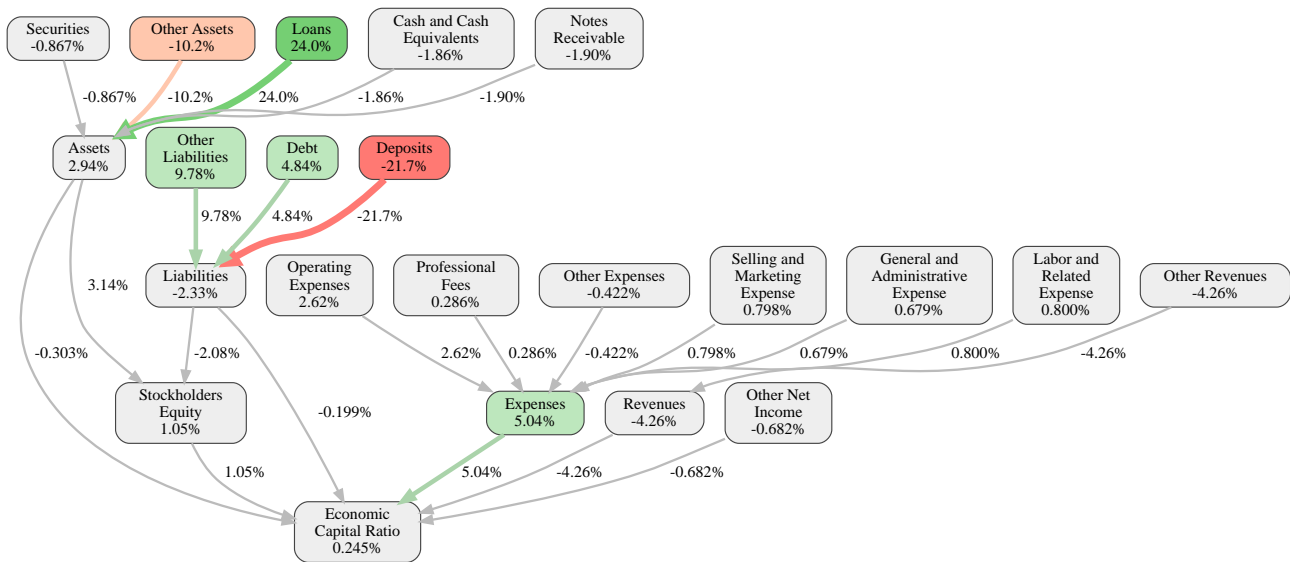

The relative strengths and weaknesses of Equitable Financial Corp. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Equitable Financial Corp. compared to the market average is the variable Loans, increasing the Economic Capital Ratio by 24% points. The greatest weakness of Equitable Financial Corp. is the variable Deposits, reducing the Economic Capital Ratio by 22% points.

The company's Economic Capital Ratio, given in the ranking table, is 9.3%, being 0.24% points above the market average of 9.1%.
