The relative strengths and weaknesses of BROADWAY FINANCIAL CORP \DE\ are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BROADWAY FINANCIAL CORP \DE\ compared to the market average is the variable Loans, increasing the Economic Capital Ratio by 18% points. The greatest weakness of BROADWAY FINANCIAL CORP \DE\ is the variable Other Assets, reducing the Economic Capital Ratio by 11% points.

The company's Economic Capital Ratio, given in the ranking table, is 6.4%, being 3.5% points below the market average of 10.0%.
