

The relative strengths and weaknesses of FEDERAL NATIONAL MORTGAGE ASSOCIATION FANNIE MAE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of FEDERAL NATIONAL MORTGAGE ASSOCIATION FANNIE MAE compared to the market average is the variable Loans, increasing the Economic Capital Ratio by 23% points. The greatest weakness of FEDERAL NATIONAL MORTGAGE ASSOCIATION FANNIE MAE is the variable Other Liabilities, reducing the Economic Capital Ratio by 64% points.

The company's Economic Capital Ratio, given in the ranking table, is 0.61%, being 8.8% points below the market average of 9.4%.
