
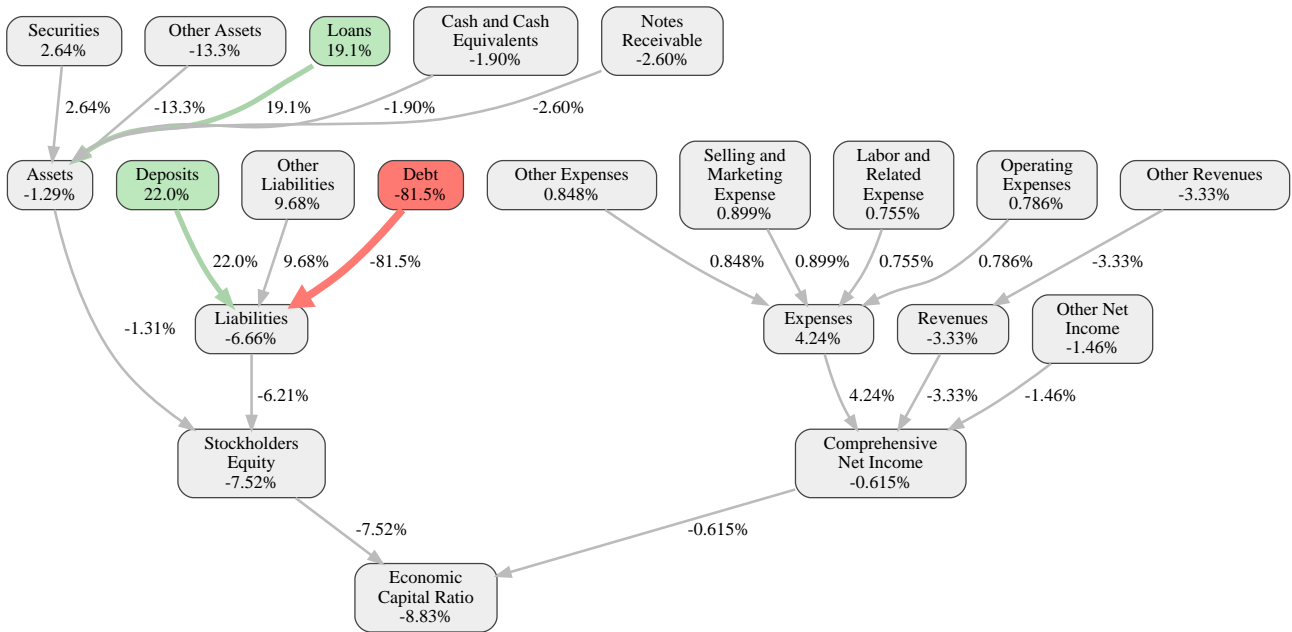

The relative strengths and weaknesses of FEDERAL HOME LOAN MORTGAGE CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of FEDERAL HOME LOAN MORTGAGE CORP compared to the market average is the variable Deposits, increasing the Economic Capital Ratio by 22% points. The greatest weakness of FEDERAL HOME LOAN MORTGAGE CORP is the variable Debt, reducing the Economic Capital Ratio by 81% points.

The company's Economic Capital Ratio, given in the ranking table, is 0.56%, being 8.8% points below the market average of 9.4%.
