

## GREENE COUNTY BANCORP INC Rank 74 of 90

The relative strengths and weaknesses of GREENE COUNTY BANCORP INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GREENE COUNTY BANCORP INC compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 11% points. The greatest weakness of GREENE COUNTY BANCORP INC is the variable Deposits, reducing the Economic Capital Ratio by 28% points.

The company's Economic Capital Ratio, given in the ranking table, is 5.2%, being 5.9% points below the market average of 11%.
