

The relative strengths and weaknesses of OneMain Holdings Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of OneMain Holdings Inc. compared to the market average is the variable Notes Receivable, increasing the Economic Capital Ratio by 37% points. The greatest weakness of OneMain Holdings Inc. is the variable Debt, reducing the Economic Capital Ratio by 71% points.

The company's Economic Capital Ratio, given in the ranking table, is 12%, being 0.91% points above the market average of 11%.
