





The relative strengths and weaknesses of SOLITRON DEVICES INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SOLITRON DEVICES INC compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 126% points. The greatest weakness of SOLITRON DEVICES INC is the variable Other Expenses, reducing the Economic Capital Ratio by 115% points.

The company's Economic Capital Ratio, given in the ranking table, is 463%, being 316% points above the market average of 147%.
