

## KULICKE & SOFFA INDUSTRIES INC Rank 20 of 72



The relative strengths and weaknesses of KULICKE & SOFFA INDUSTRIES INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of KULICKE & SOFFA INDUSTRIES INC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 135% points. The greatest weakness of KULICKE & SOFFA INDUSTRIES INC is the variable Other Expenses, reducing the Economic Capital Ratio by 61% points.

The company's Economic Capital Ratio, given in the ranking table, is 341%, being 324% points above the market average of 16%.
