

The relative strengths and weaknesses of Huaizhong Health Group Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Huaizhong Health Group Inc. compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 1,001% points. The greatest weakness of Huaizhong Health Group Inc. is the variable Other Expenses, reducing the Economic Capital Ratio by 1,471% points.

The company's Economic Capital Ratio, given in the ranking table, is 449%, being 1,005% points above the market average of -556%.
