

## SB ONE BANCORP Rank 127 of 172



The relative strengths and weaknesses of SB ONE BANCORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SB ONE BANCORP compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 69% points. The greatest weakness of SB ONE BANCORP is the variable Loans and Leases Receivable, reducing the Economic Capital Ratio by 24% points.

The company's Economic Capital Ratio, given in the ranking table, is 5.9%, being 0.98% points below the market average of 6.9%.
