

## MetroCity Bankshares Inc. Rank 17 of 190

The relative strengths and weaknesses of MetroCity Bankshares Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MetroCity Bankshares Inc. compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 18% points. The greatest weakness of MetroCity Bankshares Inc. is the variable Liabilities and Borrowings, reducing the Economic Capital Ratio by 22% points.

The company's Economic Capital Ratio, given in the ranking table, is 10%, being 2.4% points above the market average of 7.7%.
