

## MIDDLEFIELD BANC CORP Rank 117 of 180

The relative strengths and weaknesses of MIDDLEFIELD BANC CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MIDDLEFIELD BANC CORP compared to the market average is the variable Liabilities and Borrowings, increasing the Economic Capital Ratio by 8.2% points. The greatest weakness of MIDDLEFIELD BANC CORP is the variable Deposits, reducing the Economic Capital Ratio by 5.0% points.

The company's Economic Capital Ratio, given in the ranking table, is 5.9%, being 0.69% points below the market average of 6.6%.
