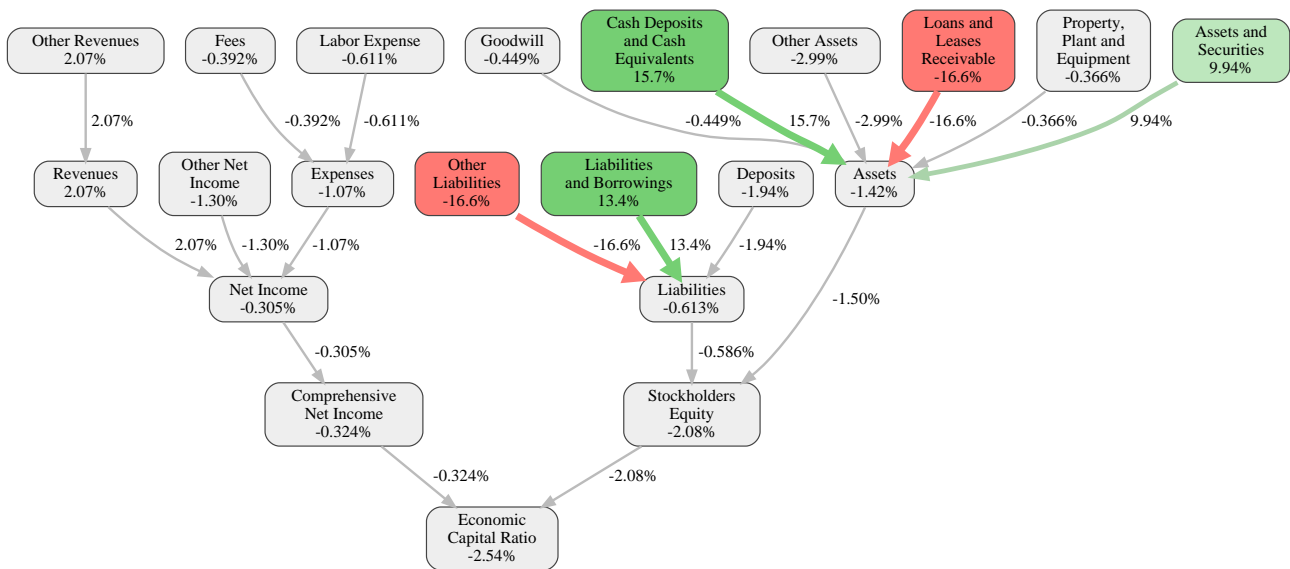

The relative strengths and weaknesses of NORTHERN TRUST CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of NORTHERN TRUST CORP compared to the market average is the variable Cash Deposits and Cash Equivalents, increasing the Economic Capital Ratio by 16% points. The greatest weakness of NORTHERN TRUST CORP is the variable Other Liabilities, reducing the Economic Capital Ratio by 17% points.

The company's Economic Capital Ratio, given in the ranking table, is 4.0%, being 2.5% points below the market average of 6.5%.
