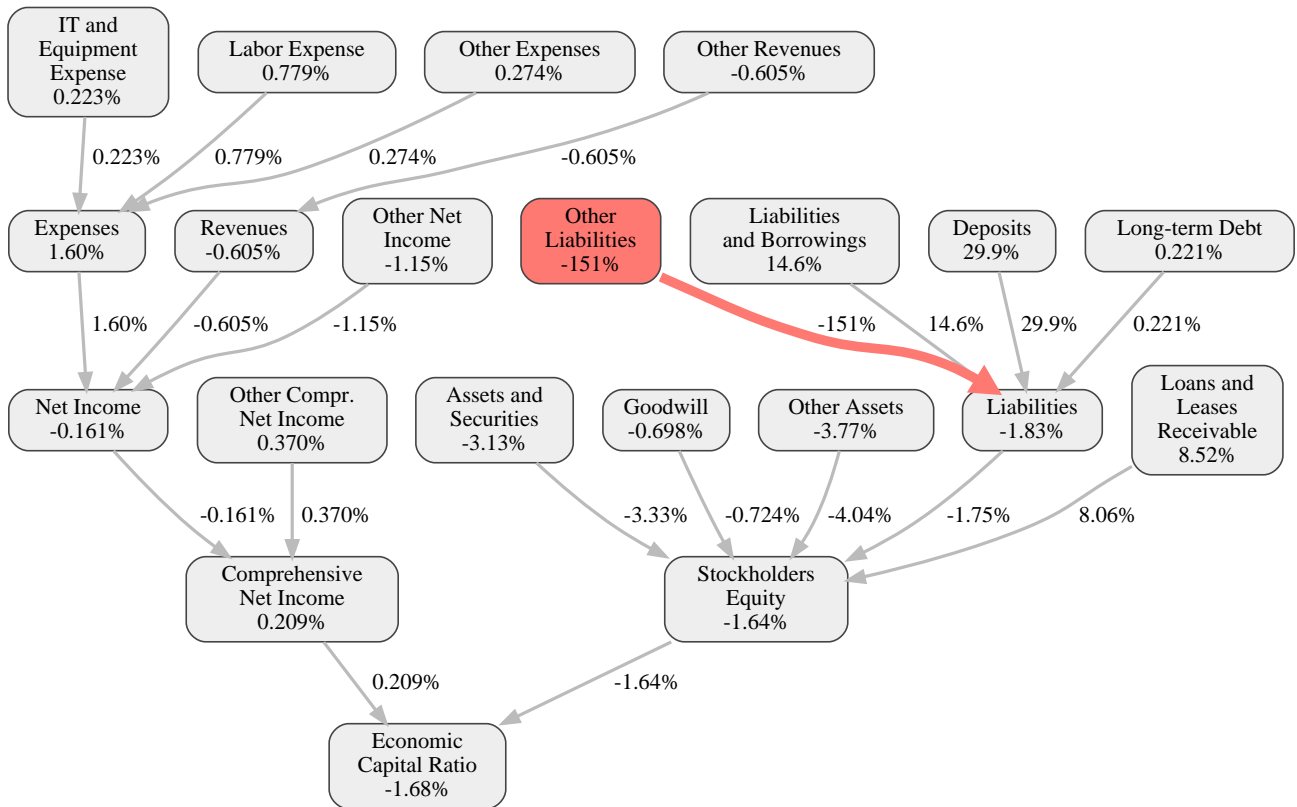

The relative strengths and weaknesses of EAGLE FINANCIAL SERVICES INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of EAGLE FINANCIAL SERVICES INC compared to the market average is the variable Deposits, increasing the Economic Capital Ratio by 30% points. The greatest weakness of EAGLE FINANCIAL SERVICES INC is the variable Other Liabilities, reducing the Economic Capital Ratio by 151% points.

The company's Economic Capital Ratio, given in the ranking table, is 2.9%, being 1.7% points below the market average of 4.6%.
