



The relative strengths and weaknesses of Tectonic Financial Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Tectonic Financial Inc. compared to the market average is the variable Other Net Income, increasing the Economic Capital Ratio by 6.7% points. The greatest weakness of Tectonic Financial Inc. is the variable Expenses, reducing the Economic Capital Ratio by 6.8% points.

The company's Economic Capital Ratio, given in the ranking table, is 11%, being 6.6% points above the market average of 4.6%.
